Jesse Norman has been promoted to transport minister following the sudden resignation by Jo Johnson. Johnson revealed he would be resigning due to concerns surrounding Brexit and calls for a second referendum on the matter.

Norman was previously Parliamentary Under Secretary of State for the Department for Transport from June 2017 to 9 November 2018.

He was elected as the MP for Hereford and South Herefordshire in May 2010.
